I release, and hereby agree to indemnify, defend, and hold harmless the University, its agents, employees, licensees, and assigns (the “Released Entities”) from and against any and all claims that I, or any third party, may have now or in the future for invasion of privacy, right of publicity, copyright infringement, or defamation arising out of the publication, use, exploitation, reproduction, adaptation, distribution, broadcast, or display of the Digital Resources described herein.

I am of full legal age and competent to contract in my own name. I understand that my authorization is granted in perpetuity and on a worldwide basis, and that the University may use the Digital Resources indefinitely without further notice or compensation to me except as expressly provided herein. I have read this Multimedia Waiver and Release, I am fully familiar with its contents and the meaning and effect thereof, and I agree to be bound by its terms. This instrument shall be governed by and construed in accordance with the laws of the State of Texas, without regard to its conflict of law provisions. If any provision of this Release is held invalid or unenforceable, the remaining provisions shall continue in full force and effect; provided, however, that if the release set forth above is held unenforceable in whole or in part, the University shall

retain the right to cease use of the Digital Resources. The University's rights under this Release shall survive the termination of any related agreement between the parties.
